Everything You Need to Know About Tax Compliant E-Invoicing

If you are not already acquainted with e-invoicing requirements, such as Continuous Transaction Control (CTC), across Europe, now is the time to put it on the agenda!

WHY IS TAX COMPLIANT E-INVOCING IMPORTANT?

Tax authorities around the world are continuing to impose new requirements to increase controls on the transactions of companies.

One example is Italy: All invoices sent from your Italian subsidiary to B2B customers within Italy must be registered in the so-called SDI portal where the invoices are verified before they are either forwarded to your customer, or your customer can log on to the portal and retrieve them.

These scenarios where invoices need to be passed via an authority for verification are referred to as Continuous Transaction Controls (CTC).

The aim of CTC is to increase efficiency and fight fraud. This is creating huge pressure for businesses to implement global e-invoicing in a consistent, scalable, and cost-effective manner.

Another model is “Post Audit”. When Post Audit is applied, the authorities are not involved in the process of exchanging invoices or other data between the trading partners; instead, they can audit the compliance of the process after the exchange.

WHO IS IT IMPORTANT TO?

The topic of efficient, timely, and compliant electronic invoicing is particularly relevant for global and multinational companies.

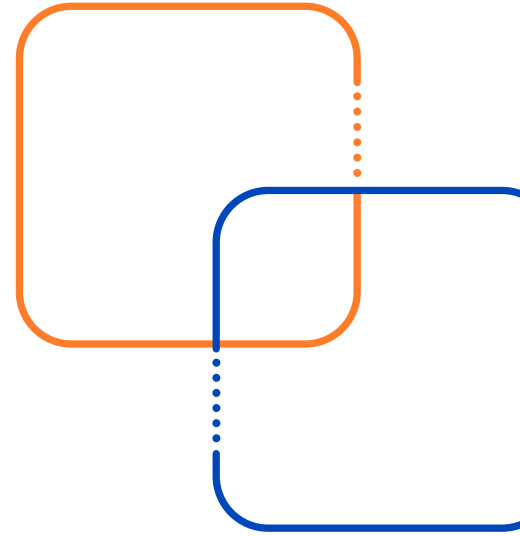
If your organization has subsidiaries in multiple countries, especially within Europe, you need to start thinking about how to automate, centralize, and streamline the processes needed to meet the ever-changing e-invoicing requirements.

WHAT IS ELECTRONIC INVOICING?

Electronic invoicing refers to the electronic sending/reception of invoices e.g., between a private company delivering their products to a customer from the public sector. Electronic invoicing is supported by all common EDI solutions, and even though electronic invoicing has historically been a requirement within the public sector, an increasing number of private companies have adopted the use of electronic invoices.

The map below shows the current status across Europe. France, Spain and Croatia are planning to introduce CTC as an e-invoicing requirement from 2025, and Poland will be implementing CTC from July 2024.

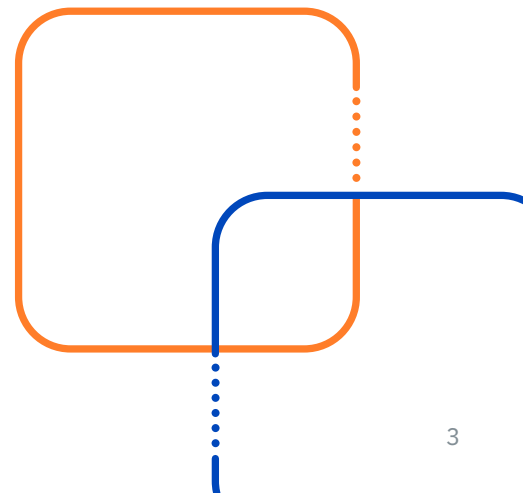
CHECKLIST: ARE YOU ALL SET FOR COMPLIANT E-INVOICING?

THE TWO TYPES OF E-INVOICING FLOWS

Continuous Transaction Control (CTC)

The e-invoicing flow using Continuous Transaction Controls (CTC) looks as follows:



TrueCommerce receives the invoice from our customer and checks the geographic location of the recipient.

TrueCommerce then forwards the invoice to our compliance partner.

Our compliance partner passes the invoice on to the portal of the local authorities who will check the invoice data against existing VAT declarations.

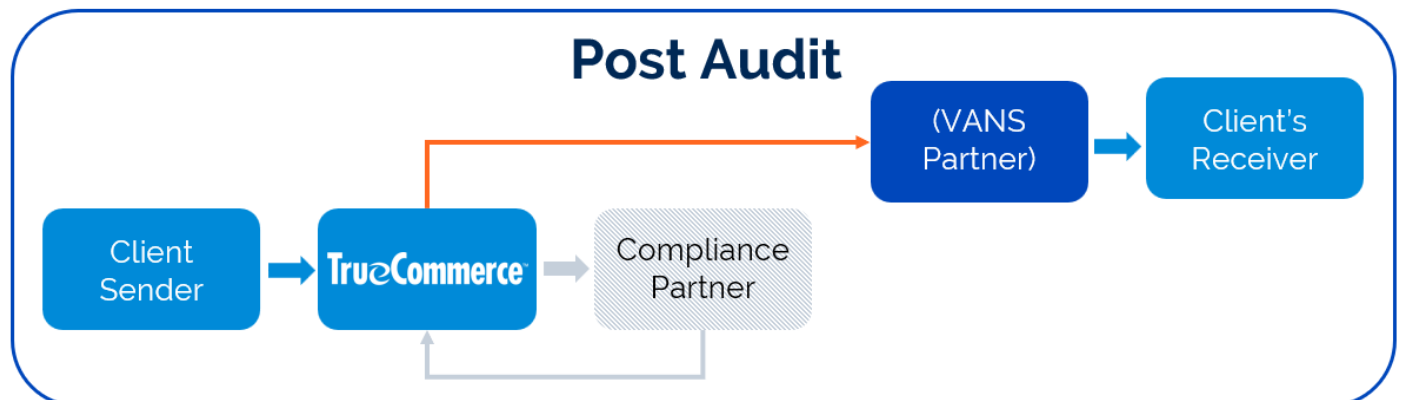
Once approved, the invoice will be forwarded to the recipient.

Here invoices must be sent through a central portal of the government.

Post Audit

In most cases, TrueCommerce will support the entire flow and send the invoice from our customer to their trading partner, either directly or via a VANS partner.

However, some countries require for the invoice to be signed by a trusted partner before it's forwarded to the recipient:



One example is Spain whose authorities require for the invoice to be signed by a trusted partner authorized by the local authorities before its being forwarded to the recipient. In those cases, TrueCommerce will send the invoice via the trusted partner.

PUBLIC SUPPLY CHAIN NETWORKS

NemHandel

NemHandel is the Danish national standard format for electronic invoices when trading with the Danish public sector. TrueCommerce integrates to NemHandel. We have strong expertise in electronic invoicing, and our EDI platform comes with an integration to NemHandel.

TrueCommerce's integration to NemHandel means we automatically convert your electronic invoice to the mandatory OIOUBL (NemHandel) format before we forward to your public trading partner.

PEPPOL

The PEPPOL format enables your company to send electronic invoices to public sectors across the EU what use Peppol as a network. This makes it easier for your company to trade internationally because you don't have to deal with specific standards for each country.

PEPPOL and BIS 3 is more than a format – it's an entire secured network for routing electronic documents between companies and their trading partners.

The PEPPOL network is tied together via so-called PEPPOL Access Points (typically EDI service providers). TrueCommerce is a PEPPOL Access Point, meaning that our customers can send PEPPOL invoices to other trading partners connected to the network.
